

# UP WOMEN WHO ESCAPED KHAP'S 'RAPE' ORDER RETURN HOME

**NEW DELHI/MEERUT:** The parents of a Dalit girl returned home on Tuesday after fleeing their village in UP's Bagpat three months ago over a Khap Panchayat order to rape the 23-year-old and her sister as revenge for their brother eloping with a Jat woman.

The woman approached the SC last month seeking protection, accusing the UP Police of being hand-in-glove with the Jat community.

"As of now only the parents have gone back. The others refused and continue to live under fear because the family received threats even after having approached the top court," the family's counsel Rahul Tyagi said. Tyagi said the parents ran out of money during their exile and went back to earn a livelihood but were unsure if they would be safe.

"The parents do not intend to stay in their own house at night. They might live with a friend or a neighbour," he said. In the top court, the woman had alleged the police foisted a false narcotics case on her brother under pressure from the girl's family. Even though a court gave him bail, her family was scared to go back.

The father said no one was willing to stand as guarantor fearing a backlash from the Jats but in hindsight, he felt his son was safer in prison.

"I have directed the district police to provide security to the family as well as the boy once he is released from jail," said DIG Meerut range Ramit Sharma.

# Indrani remains mum but her two accomplices provide police leads

**MUMBAI:** Indrani Mukerjea's alleged refusal to shed light in the Sheena Bora murder have prompted police to turn to her accomplices, former husband Sanjeev Khanna and driver Shyam Rai, to crack the crime.

Kolkata-based Khanna, the father of Indrani's younger daughter Vidhie, has allegedly confessed to his role in the murder. Rai was arrested on August 21 for keeping an unlicensed firearm.

Going by a quick recap of what police had said so far, INX co-founder Indrani, current wife of former media baron Peter Mukerjea, strangled Sheena in a hired car in a lane off Linking Road in Mumbai with the help from Khanna and the driver.

Indrani maintained that Sheena, who she had initially introduced as sister but later turned out to be her firstborn from a relationship with Siddhartha Das, was in the US.

It turned out to be false when Mumbai Police received a call and an email about the murder a few months ago. They got hold of driver Rai, who was dismissed

from service by then, and he took officers to the burial site where some of Sheena's remains were found. Rai had given away minutest details but a lot of dots in the trail remained to be filled to reach the big picture. His statement will be recorded before a magistrate,

making every word he says presentable in court as evidence.

Investigators were thus far almost certain Indrani was the main conspirator but they have to rely heavily on circumstantial evidence, such as Rai showing them the spot where the body

was buried, because the trail had turned cold in three years.

To make the case foolproof, police were poring over transactions and Skype accounts used by the accused, following reports that they hatched the plot through Skype.

The case was some distance away from court but police were trying to plug all holes before a judge heard it. Khanna has allegedly clammed up after his initial confession but his travel details, phone location and check-in information at Hilltop Hotel have been recovered.

Statements of Peter Mukerjea's son from his previous wife, Rahul, the victim's Guwahati-based brother, will also give weight to the case. Rahul, who shared an apartment with Sheena, told police he had dropped her at a spot near National College in Bandra on the day she was murdered.

**MUMBAI:** The inquiry into the alleged failure of Raigad police to register an Accidental Death Report (ADR) after a burnt corpse, purportedly of Sheena Bora, would consider all facets of the lapses by police officials, a senior official said.

"The probe, ordered by the Maharashtra DGP, has begun," Raigad SP Mohammed Suvaz Haque said on Tuesday.

The inquiry would consider all facets of alleged lapses by the then police officials, Haque said. "Pen police station got information about a burnt body dumped at the spot on May 23, 2012. Three constables visited the spot and conducted a spot panchnama. A doctor was called in to do a spot autopsy. The body parts found were sent to JJ Hospital in Mumbai," he said.

"A station diary entry was made, but no ADR was lodged. The inquiry will find out why an ADR was not registered," Haque said. The SP had recently said a preliminary probe found that the police also did not collect the report from the JJ Hospital's anatomy department, as required. The inquiry will also try to find out why the report was not collected. **PTI**

# Khanna's bank details gathered, police to probe motive

**MUMBAI:** Mumbai Police believe the murder of Sheena Bora allegedly by her mother Indrani Mukerjea was financially motivated and are days away from establishing a motive, sources said on Tuesday, as investigators scanned the former media tycoon's ex-husband Sanjeev Khanna's bank details for clues. Three police teams have been camped in West Bengal,

Guwahati and Jharkhand to comb through Khanna's financial statements and investment papers to unearth a financial motive behind the gruesome murder. The wife

of former Star India CEO Peter Mukerjea was reportedly unhappy about Sheena and her stepson Rahul Mukerjea being in a relationship and feared if they married, Peter would transfer his wealth to the due and her daughter with Khanna, Vidhie, would be excluded, sources said. This allegedly made her convince Khanna to kill Sheena, they added.

The high-profile murder has gripped the nation since Indrani was arrested on August 25 in connection with Sheena's death,

three years after the 24-year-old was strangled and her body burnt and dumped in a forest in Raigad.

Investigators say the crime was allegedly carried out by the INX media co-founder, her driver Shyam Rai and Khanna. Officials said they were given to believe Indrani was planning an off-shore venture in Singapore, for which she had asked Sheena to give back money the former media tycoon had allegedly parked in the daughter's account. An expert team of officers is attempting to

put together the pieces of the financial puzzle while two other teams are busy gathering documents. Police also said Khanna received direct cash payment to get involved in the murder and were ascertaining the exact amount. Apart from unearthing possible business ventures, officers feel banking details, sale deeds, and MoU's signed by Khanna after April 24, 2012 - the day Sheena's body was reportedly dumped - would unravel the motive.
